A NEW AND USEFUL LAW FOR SERVICE OF LEGAL PROCESS ON FINANCIAL INSTITUTIONS

California Code of Civil Procedure Section 684.115 went into effect on January 1, 2013 with the lofty goal of assisting judgment creditors with their attempts to levy on bank accounts, and aiding litigants to complete service of legal process on financial institutions. Whether a new wrinkle develops because of California's restructuring of departments remains to be seen.

Under former law, a judgment creditor attempting to levy on a judgment debtor's bank account would have to determine a specific bank branch location for the judgment debtor's account, and then arrange for service at that location. Banks wise to the very precise requirement would simply mark the memorandum of garnishee with "Nothing to Report" or "No Account Found" if the judgment creditor selected the wrong branch even if the judgment debtor maintained an account with the bank.

Code of Civil Procedure Section 684.115 requires financial institutions with nine or more branch offices in California to designate one or more central locations for service of legal documents such as levies, attachments and garnishes. Those financial institutions are required to file the designation with the California Department of Financial Institutions.

The financial institutions are required to designate the physical address and the days and hours for accepting service, plus include any limitations on the service of process being accepted. Such limitations can include service related for deposit accounts and safe deposit boxes, but even then financial institutions are required as provide specific information for acceptable service of process locations. As an added incentive for financial institutions to obey the law, the statute states that if a financial institution does not comply, then each branch for the financial institution located in California will be deemed to be a central location for service of legal process.

Specific information contained in each financial institution's designation is available on the State of California's website. Financial institutions with less than nine locations may voluntarily participate by designating a centralized location. The procedure is welcome news for any attorney who has experienced the frustrations with serving legal process on banks for various purposes.

Whether financial institutions will challenge if they are still required to submit designations for service of legal process remains to be seen. Under Section 684.115, financial institutions are required to file their notices of designations with the "Department of Financial Institutions." However, the "Department of Financial Institutions" technically doesn't exist anymore since, as of July 1, 2013, California's Governor merged the Department of Corporations

and the Department of Financial Institutions into the new "California Department of Business Oversight." One of the Department of Business Oversight divisions is entitled "Division of Financial Institutions" which arguably does not correspond to the statute's very specific "Department of Financial Institutions." Let's keep our fingers crossed that the law will be amended to correct this technicality before banks attempt to take advantage of it.

CIVIL LITIGATION SECTION MCLE UPDATE

On July 18, 2013, the Civil Litigation Section hosted the MCLE program "Top 10 California Legal Ethics Rulings of 2012-2013". The speakers were attorneys Daniel Eaton, David Majchrzak, Edward McIntyre, Wendy Patrick, and Leah Strickland, five of San Diego County's most distinguished attorneys on the subject of legal ethics.

The speakers provided an overview and lively discussion of recent court rulings in several practice areas: family law, personal injury, intellectual property, bankruptcy, real property and consumer class actions. The legal ethics issues presented included discoverability of attorney-directed witness statements, ethical duties of co-counsel brought into a litigation team for trial, when pre-litigation attorney demand letters may constitute criminal extortion, recoverability of prevailing party attorney fees for defense by a law firm's "of counsel" attorney, client solicitation in class action lawsuits, inadvertent disclosure of privileged electronically stored information and the attorney's duty of care, and attorney liability on a conspiracy theory for taking action on behalf of the client.
