10 Things to Keep in your Briefcase

- **1. Contact information**. Keep a list of the names, numbers (including cell phone numbers) and e-mail addresses of persons you may need to contact, including your paralegal, legal assistant, opposing counsel, court reporter and related personnel. You never know when your blackberry or laptop may become less than reliable.
- **2. Power cords.** Keep an extra power cord for your phone, and possibly your laptop and an extra phone line cable.
- **3. Spare change**. A roll of quarters may come in handy for meter parking or vending machines.
- **4. Protein bars**. You will be caught in traffic, or be stuck late in a deposition and you will be hungry.
- **5. A good book**. A novel or a book on leadership is good to keep handy for any dead time. If you have a Kindle, keep it in your briefcase.
- **6. Office supplies**. Keep extra legal pads, pens, post-its, paper clips, etc. You always want to be prepared.
- **7. Business Cards**. To hand out to witnesses, opposing counsel and court reporters.

BARRISTER 'ROUND TOWN

Drew L. Lyman, a local bankruptcy attorney, presented the April 2012 MCLE brown bag for the Family Law Section. He provided many helpful practice pointers for family law attorneys to use in their daily practice. One of the subjects discussed by Mr. Lyman in the presentation, "Cross-Over Issues between Bankruptcy and Family Law" was the automatic stay. The automatic stay protects debtors from the continuation or enforcement of certain collection proceedings against the debtor or the debtor's property that could have been commenced before the bankruptcy petition was filed. Mr. Lyman reminded that the stay arises automatically under federal law, without further order, upon the filing of the petition. Of course, under family law, those proceedings not affected by the automatic stay are: paternity cases, child and spousal support matters, custody and visitation cases, domestic violence restraining orders, and "status-only" dissolutions. However, Mr. Lyman also reminded that one can seek relief from such a stay, but would have to file for such relief in Bankruptcy Court, since relief is granted in some circumstances. Under In Re Schwartz, 954 F.2d 569, 571 (Ninth Circuit, 1992), any actions taken in violation of the stay are per se, void. Such violations may also give rise to sanctions or contempt. Another matter discussed was the apparent injustice of spouses in the middle of negotiating a marital settlement agreement, who just happen to file for bankruptcy after such negotiations commence. When this occurs, the filing spouse's community property and separate property interests will be included in the bankruptcy estate.

Of course, a bankruptcy does not discharge any domestic support obligations, such as child or spousal support (as stated in

II USC 523 (a)(5)). For bankruptcy purposes, a Chapter 7 Estate includes all legal and equitable community or separate property interests of the debtor, regardless of where the asset is, or who is holding it at the time the petition is filed.

The event proved to be highly informative, especially as so many more family law cases these days are carrying bankruptcy issues which the family law practitioner cannot ignore.

San Diego Superior Court Judge Seat 25 Candidate George Schaefer

George Schaefer is a Deputy City Attorney at the San Diego City Attorney's Office. George is assigned to the Special Litigation Section of the Civil Division and handles major civil cases. Examples of cases he handled include the successful defense of San Diego in the federal Mt. Soledad cross case and the La Jolla Children's Pool cases. Last year Schaefer successfully defended the City in a two-week federal jury trial and in a five-week state jury trial. In both cases, San Diego employees claimed unlawful discrimination.

Before becoming a Deputy City Attorney, Schaefer ran private law practice for over 17 years. "I fully understand the pressures place on sole practitioners, including making payroll," Schaefer noted. Schaefer added that judges need to treat attorneys, clients, witnesses, and courtroom staff with courtesy and respect at all times and accommodate lawyers' scheduling conflicts to the extent possible.

Prior to private practice, Schaefer was an Assistant Public Defender and District Attorney in other jurisdictions. In addition to handling several death penalty cases, Schaefer's prosecution and criminal defense work includes murder, rape, and child sexual abuse cases. Schaefer commenced his legal career by serving a year as a Volunteer In Service to America ("VISTA") attorney, primarily representing indigent clients with family law matters.

During the 30+ years he practiced law, George Schaefer had 112 jury trials and 125 appeals in both federal and state courts. It is the diversity of legal experience that the Schaefer campaign contends makes George well qualified to fairly and impartially dispense justice in both civil and criminal cases.

Under Robert's leadership prosecutors, law enforcement and probation officers aggressively investigated and prosecuted thousands of gang members, repeat and violent offenders. Robert also started the Drug Endangered Children's Program which has been responsible for saving hundreds of children from drug infested homes.

Robert is committed to the education of attorneys and law enforcement. He regularly teaches for the Peace Officer Standards and Training "Institute of Criminal Investigation" program in the areas of Search Warrants, Search and Seizure, Case Preparation, Courtroom Testimony, Informants, and Burglary. He has also taught for the California Narcotics Officers' Association, the San Diego Association of Public Safety Dispatchers, and the California District Attorneys Association. His legislation on W&I 777 was enacted as part of Proposition 21.

Robert has received numerous awards for his work as a prosecutor, including the Sheriff's Meritorious Unit Citation for his work in the Chelsea King investigation and an award from the FBI for his work on the 99 cent arsons. He is a lifetime member of the California Narcotics Officers Association. Robert has been involved in Tecolote Youth Baseball for over 20 years where he has served as president, treasurer, coach and currently as historian. He has also coached Pop-Warner Football and was an assistant cub-scout den leader.

San Diego Superior Court Judge Seat 25 Candidate James Miller
