SAN DIEGO COUNTY SMALL CLAIMS ADVISORY INFORMATION

The San Diego County Small Claims advisory provides free legal advice for small claims litigants throughout the county. Each of the four walk-in advisory locations is staffed with at least one licensed attorney. Additionally, the small claims central division, located in Kearney Mesa and managed by Jay Sacks, the county's supervising small claims attorney, provides a phone bank for individuals seeking assistance who are unable to utilize the assistance of the walk-in advisory.

COURT FILING FEES INCREASE EFFECTIVE NOVEMBER 1, 2010

The Superior Court has increased many of their filing fees effective November 1, 2010. Fees for complaints & answers in unlimited cases, civil harassment, family law petitions & responses, most probate petitions, conservatorship and guardianship of estate are now \$395.

Complaints & answers in limited cases (10k to 25k) are now \$370 and those up to \$10,000 are now \$225. Unlawful detainer pleadings are \$240. Motions for Summary Judgment in any legal arena are now \$500. Guardianship of the person only are now \$225.

Motion fees, certification fees, etc. have all stayed the same.

Please include the new filing fee in those cases presented for filing after November 1, 2010 or else they will be rejected by the clerks.

CATCH THIS

The FBA Family Law Section's September 2010 brown bag lunch and learn seminar hosted Andrea Scripps, the San Diego Volunteer Lawyer Program staff attorney for the East County Domestic Violence Clinic. Ms. Scripps has been tending the clinic for two and a half years. It's easy to see that she enjoys her work and is very knowledgeable on the subject. It sounds like she has seen just about every fact situation that involves a possible restraining order.

Ms. Scripps had a great powerpoint presentation handout of every aspect of a restraining order. She points out that these orders restrain the majority of the restrained parties but that some parties ignore the document. Driving home that point, she states that during the time that she has been at the clinic there have been two people who have filed restraining orders in her clinic that were killed by the restrained party. There is always that realization that we must treat each threat as serious and could be carried out by a party.

Some points:

She mentioned that 12 year olds can file a restraining order and present their case, as long as they have a guardian ad litem.

The case of *Nakamura v Parker* 156 CalApp 4th 327 resulted in the requirement that the courts now must state their reasons for denying a request for a restraining order on form DV-109.

One cannot obtain a restraining order for someone else even if they have a power of attorney, such as an elderly person.

The FBA Family Law section greatly appreciates Ms. Scripps' enthusiasm and time devoted to our Family Law section.

The FBA Family Law Section's October 2010 brown bag lunch and learn seminar hosted Thea Glazer, a Certified Financial Planner and Certified Divorce Financial Analyst. Ms. Glazer has been practicing over 25 years in her profession, including in the collaborative law area. She has a master's degree in accounting. She provides financial advising, forensic analysis and business valuations in divorce cases. She has testified as an expert witness numerous occasions. She spoke to our members in May 2008 and was kind enough to share her knowledge, expertise and enthusiasm for the subject again.

It was quite evident that Ms. Glazer knew her subject well. In fact, she 'loves' what she does. Her handouts included detailed examples of a 401k Profit Sharing Plan, a Retirement Plan Analysis, and a Stock Option Community Property Analysis.

Ms. Glazer instructed that stock options have a maze of complications regarding vesting, being qualified, transferability, and tax consequences. Ms. Glazer can help you consider these issues and develop a post-divorce financial plan for your client.

Remember, the Family Law section seminars are free to FBA members, who pay only \$55 for yearly dues. Plus, you get MCLE credits for the seminars.
